**Bay State Community Services Awarded
Community Service Agency Contract
*33 Children and Families Already Receiving Services***

QUINCY, MA – August 31, 2009 – As part of the Executive Office of Health and Human Services (EOHHS) Children’s Behavioral Health Initiative (CBHI), Bay State Community Services (BSCS) was awarded a Community Service Agency (CSA) contract for the Quincy area in March, 2009. Since then, BSCS worked to make sure the Temple Street location was ready for the June 30 program commencement date.

“Today, we have a team of employees providing intensive Care Coordination and Family Support and Training services to 33 Quincy-area children and their families”, said Kenneth Tarabelli, President and Chief Executive Officer of Bay State Community Services. “Bay State is happy to be one of 32 CSAs throughout the state that will assist an estimated 15,000 children under the age of 21 who are enrolled in MassHealth Standard and CommonHealth.”

The Children’s Behavioral Health Initiative came about as a result of the 2006 *Rosie D.* court decision and the subsequent *Rosie D.* remedial plan, which outlines the road to reform of the children’s mental health system in Massachusetts. It is because of this that Bay State Community Services is able to offer this integrated system of coordinated services to all Medicaid-eligible children with a serious emotional disturbance (SED).

“This is the most phenomenal resource I’ve seen to date for parents of children with mental illness”, said parent family partner, Cathy Sullivan. “For the first time ever, parents are able to connect to support networks and resources from one main source. This side by side team approach allows for advocating, educating and empowering parents to take control of their child’s mental health needs. As a parent who’s been there, I am thrilled to have the opportunity to help other parents and collaborate with professionals to give these kids the services they require.”

To receive services, referrals can be made to their area Community Service Agency by the family directly or with permission from the family, by the community providers (i.e. state agency staff, mobile crisis intervention, school staff, behavioral health providers, primary care physicians or residential providers. Based on the information from the referral source, the CSA Program Director will try to match the family with the best Intensive Care Coordination (ICC) team combination that can meet their cultural and linguistic needs. The ICC staff completes a Comprehensive Home-Based Assessment and CANS which assesses the family’s strengths, needs and challenges to determine eligibility into the program. If the youth is eligible for ICC, the family, care coordinator, family partner and a team of professionals and natural supports identified by the family are assembled to develop an Individualized Care Plan. The family and team in partnership determine the needs and the interventions that will be selected to meet those needs. This family-centered approach to services puts the families in the driver’s seat as the expert of their own families and children’s needs.
